

Protect the Rights and Freedoms of Utahns with Disabilities: Veto 2SHB 101

Herbert,

The undersigned individuals and organizations respectfully ask you to seriously consider vetoing 2SHB 101: Disabled Adult Guardianship Amendments. We believe the zealous advocacy of independent counsel is absolutely crucial when a person's ability to make choices or exercise control over his or her life is at stake. There are also free or low-cost representation options already available, making the legislation unnecessary.

2SHB 101 leaves it up to a judge to decide whether a person with a disability and limited assets requires counsel when his or her parent(s) is seeking guardianship. We readily admit that, in a majority of cases, parents are likely to know their adult child's wishes and have their best interest at heart. However, parents of adult children with intellectual disabilities, autism spectrum

disorder, or other disabilities are just like all other parents – some are great, some are not, some are overprotective, some are negligent, most are somewhere in the middle. The difference is what the current requirement is designed to detect and protect against.

2SHB 101 puts a proposed ward as well as a judge in a difficult position. If a parent(s) finds the guardianship process confusing and complex, what guarantees a proposed ward understands it? An attorney can help a proposed ward understand the process and what it may mean for him or her, as well as help a person express his or her wishes, strengths, skills, and needs. At the same time, the proceedings can be just as challenging for a judge. Rarely does an initial application for guardianship contain enough information on which he or she can reasonably base a decision concerning a proposed ward's ability to benefit from counsel. Additionally, he or she often relies on information from attorneys on both sides to help him or her decide whether a guardianship is necessary and, if so, what its appropriate scope should be.

Finally, finding and paying for counsel is often cited by parents as a barrier to obtaining guardianship. However, Utah's newGuardianship Signature Program provides pro bono or low bono representation to a proposed ward if he or she does not have counsel of his or her own choosing. At last count, 27 attorneys have volunteered, with several more in process. The program also utilizes students from the SJ Quinney College of Law working with an attorney advisor. Since it began in April, the Signature Program has placed 34 of 35 cases with participating private attorneys. Recognizing that a powerful motivation for the legislation is a frustration with the cost of the process, several professional and community organizations have committed to raising awareness, building the capacity,

and simplifying the operation of the program across the state in coming years.

Again, because it has the potential to unnecessarily undermine the fundamental freedoms and individual rights enjoyed by Utahns with disabilities, please veto 2SHB 101: Disabled Adult Guardianship Amendments. The financial burden on parents is nowhere near as severe as proponents of this bill have let on. If this bill is signed into law, it is very likely that within the first year we will see cases of overprotective or misinformed parents gaining guardianship over adult children who, while limited in their outward functioning, should not have their rights to self determination stripped away without zealous and independent representation.
