WINNER of "good job" award: 46: Gov. Kay Ivey awarded \$2.1 million to the state Department of Human Resources to assist elderly and disabled adults who have been abused. "No one should ever have to be the victim of abuse, and those who have unfortunately suffered from abuse need ready access to professional assistance," Gov. Ivey said. "This grant will ensure assistance for victims of physical and mental abuse." The funds will help create safe surroundings for elderly and disabled adults either by providing in-home care and supervision to enable victims to remain in their homes after offenders have been removed or relocating the victims to nursing homes or assisted living facilities.

- 1. "Assisted Living Facility's Managers Plead Guilty to Vulnerable Adult Abuse Charges" Two managers from an <u>assisted living facility in Chandler</u> have pleaded guilty to vulnerable adult abuse charges. A man died in their care after spending two days in the facility with no working air conditioning in the heat of summer. His room was 100 degrees when emergency crews arrived. 56-year-old Lolita Somera was sentenced last week to three years' probation, and 90 days in jail. After that she could be deported because she's in the country illegally. Her husband Joseph Somera is scheduled to be sentenced in December KGUN 9 November 15, 2019 (Arizona) https://is.gd/7WFw3L
- 2. "Surprise PD: Couple Arrested for Child Abuse, Accused of Zip Tying Adopted Kids and Withholding Food" Couple was arrested on Tuesday for allegedly abusing two of their six adopted children while living in the West Valley. Court records show that the Arizona Department of Child Safety contacted Surprise police on November 8, saying Lee Steven Brady, 58, and his wife Tammie Lyn Brady, 49, had been accused of abusing their son and daughter while living in Surprise from 2016-2017. During interviews with investigators, the female victim, who suffers from spina bifida and requires the use of a wheelchair or leg braces, reported that Tammie would leave her outside often and make her go days without eating. - 3. "Sex Assault Suit Names Behavioral Health Site in Arkansas" A psychiatric treatment center for children in Fordyce has been accused of negligence leading to youth-on-youth sexual assaults, according to a lawsuit in U.S. District Court in Pine Bluff. A couple filed a lawsuit against Millcreek Behavioral Health of Fordyce, saying their 7-year-old daughter was digitally raped multiple times in August 2018 by her roommate while at the center. Attorney Jered Medlock filed the

- 4. "Man Accused of Stabbing Person in Wheelchair, Trying to Set Him on Fire" A Montrose man accused of stabbing and pouring gasoline over a wheelchair-using amputee said Monday he "blacked out" after breaking a two-year stretch of sobriety. William Fritz, 55, was ordered held on a \$100,000 bond, after prosecutors said he posed a danger to the community. Fritz was arrested Nov. 15 on suspicion of attempted second-degree murder (heat of passion) and first-degree assault. - Police Responding to Man Having a Seizure, Shoot and Kill His Service Dog - Monday night, Larry Massey — likely warned by his service dog — pulled over to the side of the road before going into a seizure. When Massey would come to after losing consciousness, his service dog Butch would be dead — shot and killed by an Okeechobee police officer. - 6. "Her Child Died Amid 'Sadistic' Abuse; She was Still Allowed to Work as a Nurse in Florida" The girl's adoptive mother forced her to stand for long periods of time, arms outstretched, as if being crucified. When Samayah could take no more and dropped her arms, her mother would beat her with a shoe. Samayah's 7-year-old body had "shriveled" away from malnutrition, child welfare administrators were told, with her bones bulging from her body. When the youngster took a piece of bread, her mother burned her hands on the stove. And when Samayah was thirsty, her mother gave her bleach to drink. The Department of Children & Families verified a report that the little girl had been profoundly abused and DCF alerted administrators of a

- 7. "Man Arrested, Accused of Sexually Assaulting Intellectually Disabled Teen" A 26-year-old Villa Rica man suspected of sexually assaulting an intellectually disabled teenager was arrested Monday, authorities said. Tahji Bridges is charged with one count each of aggravated sodomy and exploiting a disabled person, Villa Rica police said in a news release. "Illinois State Board of Education Takes Emergency Action on "Seclusion Rooms" in Schools" The Illinois State Board released a press release Wednesday that they are taking emergency action on the use of isolated seclusion in schools. This comes after a scathing report from the Chicago Tribune and Pro Publica, which detailed how these seclusion rooms have been misused statewide. The intent of these seclusion rooms is to isolate children who could be a threat to themselves or others, but the report showed many schools are using what are often called "quiet rooms," for many other reasons. 25 News Week.Com November 20, 2019 (Illinois) https://is.gd/Ykqo2Z

"Update: Noblesville Schools Special Education Director Removed Over Offensive Meme" - Mark Booth will no longer serve as Noblesville Schools' director of special education, the district announced Tuesday, Nov. 26. The district cited Booth's "recent sharing online of a 'meme' offensive to special education." Over the weekend, Booth shared a Facebook meme that shows a photo of Barack Obama with the text "2008 1st black president," and an image

- 10. "Louisville High Schooler Charged in Beating of Autistic Teen" An Iroquois High School student was arrested Friday after he reportedly attacked a teenage boy with autism on Thursday.

 According to WAVE3 News, 18-year-old Damon Simmons faces charges of assault and criminal mischief. An arrest warrant for Simmons states that he, along with three juveniles attacked the victim in a school bathroom, breaking the victim's jaw. The report adds that the victim was found by another student lying in a pool of blood. The victim reportedly had to have surgery to repair his damaged jaw. "Kentucky High Schooler Pleads Not Guilty to Attack on Autistic Classmate" An 18-year-old Kentucky high schooler has pleaded not guilty to second-degree assault and criminal mischief in an assault on a reportedly autistic classmate. News outlets report Damon Simmons is accused of attacking the Iroquois High student on Thursday with the help of three juvenile students. An arrest citation says surveillance video shows Simmons and the other students enter a bathroom at the Louisville school after the victim. - 12. "Maine Panel Finds Uber Discriminated Against Blind Falmouth Woman with Service Dog" The Maine Human Rights Commission found on Monday that the ride-sharing company Uber discriminated against a blind woman when a driver refused to give her a ride because her service dog was with her. Sarchi said she had an Uber ride requested for her and her service dog, a standard poodle named Jeffrey, on Jan. 5, 2017 after a manicure in Portland. The driver refused to give Sarchi a ride after seeing her service animal, saying

- 13. "Parents Look for Answers After Autistic Son Chokes at School" A Maryland couple whose autistic teenager died after choking on a latex glove say they have concerns about the way the public school system handles students with special needs. The Capital Gazette reports 17-year-old Bowen Levy died on Nov. 10, five days after he choked on a glove at Central Special School, which serves children with disabilities in Anne Arundel County. "Parolee Accused of Sexually Assaulting Green Acres AFC Resident" A man on parole for manslaughter and living on the grounds of an adult foster care facility was arrested after he was accused of molesting a developmentally disabled resident. Jay Jeffry Stewart, 62, was arrested Sept. 12 at Green Acres, 127 Potter Road, after a female resident, 63, who suffers from severe anxiety, speech impairment and has a cognitive disorder, told a family member she was assaulted. The woman was repeatedly assaulted over several months, Green Acres staff knew of the assaults and did not stop them, according to a Department of Licensing and Regulatory Affairs investigation report. "High-Stakes Medicaid Assessments Upend Lives of Families with Disabilities" -Each year, tens of thousands of Minnesotans with disabilities and their families undergo this agonizing, high-stakes ritual, known as a comprehensive needs assessment. A stranger with a laptop comes to their home and asks hundreds of questions about the medical needs and care of their loved ones. State officials also promised that the high-tech assessments would bring objectivity and

rigor to a system that distributes more than \$3 billion to Minnesota families every year. - 16. "Troy, Mo. Man Caught Exposing Himself to Disabled 9-Year-Old Girl Pleads Guilty" A 53-year-old man has pled guilty to multiple federal charges after being caught exposing himself in front of a young girl inside a Troy, Mo. home Friday. In September of 2017, the Troy Police Department arrived to the 100 block of Harris Street after receiving a 911 call about a sexual assault. Once they arrived, a man said he walked in on his brother-in-law, Stewart Wells, with his pants down and his penis erected near his 9-year-old daughter's face. Detectives said the girl is disabled. "Police: Mother Took Mentally Disabled Daughter from Nursing Home, Stabbed Her to Death" An elderly woman who feared she was developing dementia removed her mentally disabled adult daughter from a nursing home, then fatally stabbed her in a suburban St. Louis hotel before attempting to kill herself, police and relatives say. Marjorie Theleman, 78, was charged Tuesday with first-degree murder and armed criminal action in the death of her 51-year-old daughter, Sharon Theleman, after police were summoned to a hotel in Fenton, Missouri, because the pair had not checked out. "Carson City Arrests: Caretaker Jailed for Allegedly Threatening Client with Knife" Antonio Mempin, listed as being from Carson City, was taken into custody in the 1400 block of Rolling Hills Drive. According to the arrest report, Carson City sheriff's deputies were called to a residence regarding threats with a knife that happened

Saturday, Nov. 16. Deputies met with the victim and his nurse who said on Saturday early morning, a caretaker, Antonio Mempin, came into the room with a knife. - 19. "Day Care Chain Settles Suit after Expelling Girl with Down Syndrome" Spring Education Inc., formerly Nobel Learning Communities Inc., says it will be more understanding with children with disabilities who have development delays with potty training. The national for-profit day care and school settled a lawsuit brought by the U.S. Department of Justice after the Chesterbrook Academy in Moorestown, N.J. kicked out a 3-year-old girl with Down syndrome when she couldn't conform to a corporate timeline on toilet training. "NJ Adult Day Care: 5 Employees Indicted in Abuse of Disabled Clients" According to the release, employees of the facility Asia Lunn, 22, Kenitra Hicks, 34, Kieasha Morgan 24, Hugo Lorenzo, 25, all of New Brunswick, and Janella Allen, 31, of Elizabeth were indicted on two counts of abandonment and neglect of a disabled person and two counts of endangering another person, for two separate victims, both third-degree crimes. Lunn also was indicted on a charge of third-degree aggravated assault. Their investigation determined that in May, two "severely disabled individuals" who attended the facility were physically abused allegedly by employees there. "Life or Death Information': Complaint Claims UNC Health Care Violated Patient Rights" -Potential credit damage from unpaid medical bills, disclosing private information to strangers, failing to receive complete follow-up instructions after health care visits two blind residents in North Carolina claim these are just a few of the things they experienced after the UNC Health Care system repeatedly failed to provide them with medical information in formats they could access. Detectives said the abuse came to light after a group home trip to North Myrtle Beach in September. "In North Myrtle Beach, there was a witness that happened to walk into the room and believe that they saw the victim and Ms. Bunch in a compromising position," said Claiborne. The Cleveland County Sheriff's Office said Whitney Baker, 28, has been charged with three counts of indecent liberties with a student. According to deputies, one of the incidents happened at The Turning Point Academy where Baker worked as a special needs teacher. "Special Education Teacher Placed on Leave for Allegedly Hitting Student" An Early Childhood Special Education teacher at Centennial Elementary has been put on administrative leave for allegedly hitting a student. An administrator at the school received a report of a negative interaction between a teacher and a student on November 12. Centennial Elementary administration and the Fargo Police Department are investigating the allegation. The teacher will remain on administrative leave until the investigation is complete. "State Officials Say Bixby Group Home Shut Down After Several Problems Discovered" -We have learned new details about why a Bixby group home that helps teenage girls with mental health issues shut down. State officials said the group home had a "multitude" of errors before its closure. Now parents said the shutdown is part of a bigger issue about the lack of mental health resources in Oklahoma. The Bethesda Residential Treatment Center in Bixby served girls between the ages of 12 to 18 dealing with mental and behavioral health problems. But Blish said the bigger problem is the lack of mental health resources available in Oklahoma. She said many similar group homes would only admit youth with suicidal thoughts. "Multnomah County Staff Mishandled Hundreds of Mental Health Abuse Complaints, Report Finds" Multnomah County employees in charge of protecting adults with mental health issues failed to do so on multiple fronts, according to District Attorney Rod Underhill and county officials. Those determinations, both made public Tuesday, came in the midst of a wide-ranging review in the wake of findings that county staff knew about deaths and abuse at the main psychiatric facility in the county yet did nothing. It showed, among other things, that county workers completely dropped the ball in nearly 100 instances of reported abuse of people with mental illness by failing to investigate at all and failed to tell police of 136 reports of alleged criminal conduct. "'Obscene and Disturbing': Lawsuits Filed Against McGuire Memorial, 2 Ex-Caretakers Accused of Filming Abuse" A Beaver County care facility and two of its former caretakers are facing four lawsuits alleging the abuse and assault of four people with physical and mental disabilities. Lawyers filed the lawsuits Friday morning against McGuire Memorial in New Brighton and its former employees, Zachary Dinell and Tyler Smith. The alleged incidents happened between 2017 and 2018; however, the lawsuits say the victims' families didn't learn of them until "well after it occurred." According to the lawsuits, one of the victims was just 13-year-old at the time of the alleged abuse. Lori Elaine Johnson, 62, was served a sealed indictment on Tuesday, November 20 and booked into the Montgomery County Jail charged with five counts of aggravated child abuse (victim under 8-years-old). "Feds: Ex-TDOC Officers Who Beat Mentally III Inmate and the Corporal Who Helped Cover it up Face Charges, Prison" A fourth former Tennessee Department of Corrections officer pleaded guilty to involvement in the February assault of a mentally ill inmate at a Tiptonville prison. Another former officer and a corporal allegedly involved in the assault face additional charges in a new indictment. Five officers at the Northwest County Correctional Complex entered the cell of a man on suicide watch and took turns repeatedly punching him "like a piñata" without cause, according to the office of U.S. Attorney D. The most significant addition under this amendment impacts recipients in the Housing Choice Voucher Program of the Housing and Community Development Act of 1978 ("Section 8 Voucher Program"), which an estimated 300,000 Californians currently receive. "Audit Finds NY State Agencies Failing to Properly Inform Parents of Incidents of Abuse at State-Run Facilities for Disabled" - Parents are being left in the dark when it comes to abuse and neglect at state-run facilities for the disabled, according to an audit released Monday by Comptroller Thomas DiNapoli. Investigators with the comptroller's office found that facilities operated, licensed or certified by the state's Office for People with Developmental Disabilities repeatedly failed to properly notify parents and guardians about

incidents as required by a 2007 law. The agency is the second to be flagged this year by DiNapoli for failing to comply with Jonathan's Law, named for Jonathan Carey, a 13-year-old non-verbal autistic and developmentally disabled boy who died while in the care of a state facility. "The state must do everything it can to protect individuals with disabilities in their care," DiNapoli said. "Jonathan's Law was created to make sure incidents of abuse and neglect are properly addressed and families are told of what occurred.
